5a. Monitoring activities

- Waterfowl
 - -2016: 26.08, 228 ind. birds, to 12 species; 02.09, 251 ind., 16 species.
 - 2017: 24.05, 2110 individuals of 46 species; 01.06, 1237 ind., 38 species.
 - Next autumn observations: 25th of August and 05th of September 2017.
- Golden Eagle
 - NO: NINA research institute has mapped Golden Eagle and other birds of prey in 2016 (2 reports finalised and data in Rovbase - see own slide) - cont. same action in 2017 FMFI funding
 - FI: Metsähallitus has monitored breeding in 2017 see own slide
- Brown Bear: no joint trilateral action in 2016/2017 next time in 2019

–NO: hair-trapping in Sametti area in 2016 - NIBIO report finalised (see own slide). NIBIO actions in 2017 (own presentation by Paul/ Anne).

• **Bird ringing**: results and future work will be discussed in North Calotte GBFworkshop in Norway in September 2017

–NO: Biotope and Breewood ringers cooperation. 2015: 3923 birds ringed/ 36 species. 2016: periode 361 birds ringed/ 25 species

-RU: 2016 - 318 adult birds belonging to 24 species

-FI: Local branch of Association of Nature Conservation in Finland and volunteers in Ivalo; 2016: results not yet available; 2017: from end of August until mid-September

FMFI funded actions, implemented by NINA and SNO (Alta) 2 reports in Norwegian. Results in Rovbase. Same action in 2017 FMFI



Golden Eagle in Finland

- Breeding result in the Northern Finland was bad as well as in the Northern Sweden,too – Food, weather or some other reasons?
- Inari-Utsjoki area has been monitored by helicopter
 - Totally 65 occupied territories but only 10 successful breedings and 11 young
 - 2007-2016 9-30 successful breedings/year
 - In "Finnish trilateral area" 11 occupied territories and three successful breedings and three young

Sametti hair-trapping in 2016 - results

Using same "trilateral" system. 20 hair traps. obtained 77 samples: 10 bears identified (6 females and 4 males): 5 known bears and 5 new (4 females and 1 male).

5b. Enlightenment actions

- New Visitor Center in Nikel:
- It was built in 2011-2016; Visitor Center was constructed and equipped at the end of 2016. It was funded by the Ministry of Natural Resources and the Environment of the Russian Federation, Nornikel and Kolsk mining company. Total funding was around 96 million roubles.
- The Visitor Center was accepted as satisfactory by the Russian Government inspection on 17 January 2017 and the Year of the Ecology in Russia has started with this event.
- The international celebration in honor of opening the center to the public was held on 15th of March 2017 and it was dedicated to 25 year anniversary of the Pasvik Reserve and the 100-year anniversary of the Russian Nature Protection System.
- Trilateral bird watching trips
 - altogether 29 participants on a cold and snowy day in three countries. Norway won with result of 50 species and 664 bird individuals - congrats!

 - Visitor survey: translated questionnaires, on hold
 - Hunting database in preparation
 - Buffer zone of the Pasvik Reserve in future. Also the regional protected area the Nature park "Korablekk" - was established in April 2017. Pasvik Reserve experts were involved in this work and preparation of the documents.
- Annual meeting of Transboundary Parks
 - "Changing Climate, Changing Parks" in Julian Alps Transboundary Ecoregion (IT/SI) June 2017: radical loss of glaciers in the Alps; mitigation and adaptation to climate change
